4. HAZARDOUS AND TOXICITY CLASS

Class Name	<i>4.1.1.1 Not applicable for regulated class</i>
Hazard	<i>It may cause heat generation or electrolyte leakage if battery terminals contact with other metal. Electrolyte is flammable. In case of electrolyte leakage, move the battery from fire immediately.</i>
Toxicity	<i>Vapor generated from burning batteries, may make eyes, skin and throat irritate.</i>

5. FIRST AID MEASURES

The product contains organic electrolyte. In case of electrolyte leakage from the battery, actions described below are required.

Eye Contact	<i>5.1.1.1 Flush the eyes with plenty of clean water for at least 15 minutes immediately, without rubbing. Take a medical treatment. If appropriate procedures are not taken, this may cause an eye irritation.</i>

8. HANDLING AND STORAGE

<i>When packing the batteries, do not allow battery terminals to contact each other, or contact with other</i>

metals. Be sure to pack batteries by providing partitions in the packaging box, or in a separate plastic bag so that the single batteries are not mixed together.

Do not let water penetrate into packaging boxes during their storage and transportation.

The batteries will be stored at room temperature, charged to about 30~50% of capacity.

Do not store the batteries in places of the high temperature exceeding 35 degree C or under direct sunlight or in front of a stove. Please also avoid the places of high humidity. Be sure not to expose the battery to condensation, water drop or not to store it under frozen condition.

Please avoid storing the battery in the places where it is exposed to the static electricity. It may cause the protection circuit to be damaged.

Cells and batteries must be packed in inner packaging that completely encloses the cell or battery.

Cells and batteries must be protected so as to prevent short circuits. This includes protection against contact with conductive materials within the same packaging that could lead to a short circuit.

Each consignment must be accompanied with a document such as an air waybill with an indication that:

- the package contains lithium ion cells or batteries;
- the package must be handled with care, and that a flammability hazard exists if the package is damaged;
- special procedures should be followed in the event the package is damaged, to include inspection and repacking if necessary; and
- a telephone number for additional information.

Each package must be labelled with a lithium battery handling label;

Any person preparing or offering cells or batteries for transport must receive adequate instruction on these requirements commensurate with their responsibilities.

	The logarithmic frequency sweep is as follows: from 7Hz a peak acceleration of 1g_r is maintained until 18Hz is reached. The amplitude is then maintained at 0.8mm (1.6mm total excursion) and the frequency increased until a peak acceleration of 8g_r occurs (approximately 50Hz). A peak acceleration of 8g_r is then maintained until the frequency is increased to 200Hz.	
T4	Shock – Batteries were secure to the testing machine by means of a rigid mount which will support all mounting surfaces of each test battery. Each battery was subjected to a half-sine shock of peak acceleration of 150g_r and pulse duration of 6 milliseconds.
